CATEGORY C: Proof of City of Goshen Residency. Provide one (1) document of the following list.

Documents MUST be current or dated within the previous 30 days from the application date.

1. Utility (Electricity, Gas, Heating, Water or Internet) or credit card bill or statement
2. Employment record including Pay Stub, W2, W4 or earnings statement issued with the name and address of the employer
3. Federal, state or City of Goshen government issued document, letter or record
4. Financial institution account statement
5. Housing lease or rental agreement Unexpired
6. Mortgage or local property tax statement
7. Life, health, auto, home or renter insurance policy
8. Indiana title or vehicle registration
9. Letter or record from a religious organization, social services agency, domestic violence or homeless shelter located within city
10. Letter of record from a hospital or medical treatment facility addressed to applicant or letter confirming residency or services provided in the previous 30 days
11. Letter or record addressed to applicant at a Goshen address from a school, college or university located in the state of Indiana that the applicant or a child of the applicant attends.

2. Add the total number of points for each document you are considering to include in your Goshen Resident ID card application.
3. Total the number of documentary points _____.
4. You need a score of 300 points or higher to qualify for the Goshen Resident ID card.

CARD APPLICATION GUIDELINES

1. You MUST complete the card application process in person at the enrollment office
2. Knowingly providing false or misleading information to obtain the Goshen Resident ID card is against the law
3. All documentation submitted MUST be original copies with no alterations or signs of tempering
4. The Goshen Resident ID card is valid for a period of two (2) years from date of issuance

- It will help people who have difficulty getting a photo identification document in other ways
- It will provide allies of immigrant neighbors an opportunity to support them
